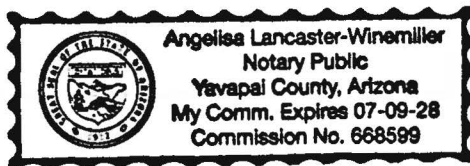
4. On May 7, 2025, the City Clerk's Office was served with the above-captioned lawsuit against the municipal corporation.


