Plaintiff hereby requests to skip April 2025's and May 2025's payment because he doesn't have the money for this month, and is unsure if the situation will change in 5 days (1 May).

1 3. Plaintiff has \$2.04 in his checking account. Plaintiff has \$6.20 in his savings

5 4. Plaintiff is not employed in the typical sense. Between the dates of 25

7 March 2025 and 25 April 2025, clients have engaged him 5 different days. At this

9 time (today, 25 April 2025), there are no clients who have engaged Plaintiff for work.

11 During this month (25 March to 25 April), Plaintiff's income has been \$401.

13 5. Plaintiff's fixed financial obligations are \$87/mo for car loan payment, and
14
15 \$172/mo for car insurance. The rest of my expenses are pretty much gas and food
16
17 which are fluctuating expenses. It should be no stretch of the imagination that the
18
19 other \$142 from the \$401 were spent on food and gas.
